

The East European Accuracy League Zamosc 2024





PATRONAT HONOROWY STAROSTY ZAMOJSKIEGO

1. The competition will take place at airfield of the Aeroclub of Zamosc in Mokre, on September 27-29, 2024. They will be conducted in accordance with the FAI rules and EEAC regulations posted on the website www.eeacup.eu.

2. The program of the competition:

27.09.2024	- 08.00-09.30	- registration of competitors,
	- 09.30-10.00	- technical briefing,
	- 10.15-10.45	- opening of the competition,
	- 11.00-18.30	- playing the competition,
28.09.2024	- 8.00-18.30	- playing the competition,
29.09.2024	- 8.00-13.00	- playing the competition,
	- 14.00	- competition closing ceremony.

Competition may end earlier if all jumps have been completed or if the weather makes it impossible to do so. The end of the competition will take place an hour after the end of the jumps.

3. The competition is organised by the Military Sport Club WAWEL, the member of Polish Aero Club – Polish Association of Air Sports and the Aeroclub of Zamosc. The organizers of the competition will be assisted by the 2nd Reconnaissance Regiment. The event will be held under the auspices of the Mayor of Zamosc, Mr. Stanisław Grześko.

Event partners are: Krakow Municipal Holding, Municipal Heat Supply Company in Krakow, National Food Industry Group, Waterworks Krakow, F.H.U. NIZBUD Mariusz Niziol, Polskie Zakłady Lotnicze Sp. z o.o.

4. The competitions:

- team accuracy landing:
- 8 rounds (minimum 4),
- teams can be mixed,
- teams are four-person,
- individual accuracy landing:
- 8 rounds (minimum 4).

5. The starting fee for the participation in the East European Accuracy League Zamosc 2024 is 160 EUR per competitor. Fees are paid at the time of registration in the competition office. The rules provide the refund in case the competition will not take place for the fault of the organizer -

including weather conditions, then we return 10 EUR for the jump of one competitor. The organizer does not allow payment in a different currency. As part of the entry fee, each participant is provided with parachute jumps and participation in a joint dinner on Saturaday.

6. Participants of the competition must have FAI sports licenses, medical examinations entitling tchem to practice parachute sports and insurance policies against civil liability related to the performance of parachute jumps.

6. The entry form – check attachment 1 - must be sent no later than 24.00 of 22.09.2024 to the following address: gosiewski@kki.pl.

7. The number of competitors is limited to 60.

8. The competition rules described in attachment 2 will be applied.

9. The jumps will be performed from the An-2 airplane and Cessna 206 airplane.

10. The organizer provides the possibility of free accommodation in their own tents at the airfield with the possibility of using electricity and toilets and a shower. The organizer offers possible assistance in booking accommodation based on nearby guesthouses, at a price of EUR 19 per person per night. The number of places is limited. The cost of accommodation in guesthouses is not included in the entry fee and is borne by the competitors induvidually. On the application, please indicate whether you will use the accommodation at the airport or in guesthouses.
